

Tournament Rules

1. Teams will consist of two bowlers, one male and one female. Both bowlers must be currently sanctioned as an **Adult Member** of USBC. **IF NOT SANCTIONED BERGEN COUNTY USBC BA, YOU MUST PURCHASE A \$10.00 OUT OF COUNTY FEE.**
2. Bowlers must use their **HIGHEST BOOK** sanctioned **WINTER LEAGUE AVERAGE**. Each bowler must use an entering average in the following manner. **(NO SUMMER LEAGUE AVERAGES)**
 - a. 2007 – 2008 **HIGHEST BERGEN COUNTY BOOK AVERAGE**, based on a minimum of 21 games.
 - b. 2007 – 2008 **HIGHEST BOOK AVERAGE** based on a minimum of 21 games.
(USBC Rule 319a-2) **TEN PIN RULE NOT IN EFFECT.**
 - c. If the bowler has no 2007 – 2008 **BOOK AVERAGE**, the bowler's **HIGHEST 21-game average**, as of **THE DAY OF BOWLING**, will be used. **YOU MUST BRING IN YOUR LATEST LEAGUE SHEET FOR AVERAGE VERIFICATION.**
(NO LEAGUE SHEET RULE 2 – d APPLIES)
 - d. Bowlers with none of the above-required averages will use an average of **230 for the Guy and 230 for the Doll.**
3. **Handicaps** will be on a team basis - **100% of 460 scratch “NO MAXIMUM HANDICAP”**
(NO TEAM MAY ENTER OVER 460)
4. **Bowlers may re-enter the tournament according to the following rules:**
 - a. No bowler may cash more than once with the same partner.
 - b. **A bowler may re-enter a maximum of 8 times.**
5. Bowlers must report 30 minutes before their scheduled squad time to have their credentials verified and receive lane assignments.
6. If there is a tie for First Place, Co-Champions will be declared and prize monies will be shared. Duplicate awards will be given.
7. Errors in scoring must be reported to the Tournament Secretary within 24 hours.
8. It is the bowler's responsibility to comply with USBC Rule 319d and USBC Rule 319a-3.
9. USBC Rule 319e (Average Adjustment) applies to all entrants.
10. **No entry will be accepted without the full entry fee of \$50.00 per team.**
11. **LANE ASSIGNMENTS WILL BE IN ORDER OF RECEIPT OF ENTRY FORM**
12. Proper bowling attire must be worn during the tournament. **Bowlers must be dressed in a neat and presentable manner. (i.e., no torn shorts, pants or shirts)**
13. **USBC Tournament Rules apply.**
14. **The Tournament Committee reserves all rights.**
