## ***TOURNAMENT RULES***

1. Teams will consist of three bowlers of any combination. All bowlers must be currently sanctioned as an Adult Member of USBC. If not sanctioned in Bergen County USBC, you must pay a \$15.00 out of county fee (no out of state checks are allowed).
2. This is a Scratch & Handicap Tournament. Handicaps will be on a team basis: 100% of 690. There is no maximum Handicap.
  - a. All teams that enter over 690 will be placed in the Scratch Division only.
  - b. Prize money will be divided as follows: 40% Scratch and 60% Handicap.
3. Bowlers must use their highest certified Summer or Winter sanctioned average. Please note that Sport averages will be re-calculated to Standard averages. Each bowler must use an entering average in the following manner with a minimum of 21 games:
  - a. 2024-2025 Highest USBC Certified Average.
  - b. 2023-2024 Highest USBC Certified Average.
  - c. If the bowler does not have a USBC Certified Average from the past two seasons but bowls in a current USBC Sanctioned league, the highest average as of the day of bowling will be used (minimum 21 game rule still applies). **The bowler must bring in their league's most current standing sheet for average verification.** If a standing sheet cannot be produced the bowler will bowl following rule 3(d).
  - d. Bowlers with no averages that qualify will use an average of 230.
  - e. Youth averages are not valid for this Tournament.
4. Tournament Within a Tournament:
  - a. This will have four separate divisions (Mens' HDCP, Mens' Scratch, Womens' HDCP, Womens' Scratch) with the scores bowled from the triples' series. The scores will count for your tournament within a tournament.
  - b. This event will pay 1 out of 7.
  - c. Any bowler that enters may only cash once per division.
  - d. Handicap when applicable will be 100% of 230.
  - e. Entry into this event will be \$25 per Bowler (expense fee \$5 included).
5. Bowlers may re-enter the tournament according to the following rules:
  - a. A bowler may cash in only one division (Scratch or Handicap) (highest monetary value).
  - b. A bowler may re-enter a maximum of Three (3) times.
6. Bowlers must report 30 minutes before their scheduled squad time to have their credentials verified and receive lane assignments.
7. If there is a tie for First Place, Co-Champions will be declared, and prize monies will be shared.
8. Errors in scoring must be reported to the Tournament Secretary within 24 hours.
9. It is the bowler's responsibility to comply with USBC Rule 319d, USBC Rule 319a-3, 4, 5, and USBC Rule 319c-1.
10. USBC Rule 319e (Average Adjustment) applies to all entrants.
11. No entry will be accepted without the full entry fee of \$150.00 per team.
12. Proper bowling attire must be worn during the tournament. Bowlers must be dressed in a neat and presentable manner. (i.e., no torn shorts, pants, or shirts).
13. Lane conditions will be a modified shot.
14. USBC Tournament Rules apply.
15. The Tournament Committee reserves all rights.
